



Boone County Board Minutes



BOONE COUNTY COMMISSIONERS SPECIAL PUBLIC MEETING JUNE 4, 2021 ALBION, NEBRASKA

The Boone County Board of Commissioners of Boone County, Nebraska, held a special public meeting at 9:30 A.M. on Friday, June 4, 2021, in the Commissioners Meeting Room of the Courthouse in Albion, Nebraska.

Chairman Temme called the meeting to order and present for roll call were Commissioners Larry Temme, Ben Rutten, and Jon Lindgren; and Brian McDonald, JEO Consulting Group, Inc. Notice of the meeting was given in advance by publication in the Albion News and Boone County Tribune and the Petersburg Press on May 26, 2021 and the convened meeting was open to the public. The agenda was posted on the Boone County website and posted on the information board located in the Courthouse north entrance on Tuesday, June 1, 2021. Chairman Temme acknowledged the agenda and noted that the Open Meeting Laws are posted and available to the public.

Brian McDonald, JEO Consulting Group, Inc., asked for a special meeting to be held before the next Commissioner's meeting on June 14, 2021 to help expedite the bid process for the Primrose South EWP, Project Nos. 190778.01 and 191578.01, that needs to be completed by August 6, 2021. The August deadline is to be in compliance with Nebraska Natural Resources Conservation Service deadlines to receive NRCS EWPP funds at the completion of the project.

Sealed bids were to be received in the County Clerk's office by 9:30 A.M., on June 4, 2021 to be eligible for review. Six sealed bids were received by the deadline and were as follows:

McDonald and the Board thanked those in attendance for their bids and stated that the apparent low bid for Site 197/Project No. 190778.01 is Husker Engineering, Burwell, NE for \$45,532.00 and the apparent low bid for Site 497/Project No. 191578.01 is Bygland Dirt Contracting, Inc., Albion, NE for \$71,866.60.

Additional time is needed to complete a bid tab and to confirm bid amounts, so no action is taken at this time. Further discussion and final decision will take place at the next commissioners meeting.

Chairman Temme declared the meeting adjourned at 10:02 A.M., with the next Board meeting scheduled for Monday, June 14, 2021.
