BOONE COUNTY BOARD OF COMMISSIONERS PROCEEDINGS APRIL 21, 2025 ALBION, NEBRASKA

The Boone County Board of Commissioners of Boone County, Nebraska, met in regular session at 9:00 A.M. on Monday, April 21, 2025, in the Commissioners Meeting Room of the Courthouse in Albion, Nebraska.

Chairman Lindgren called the meeting to order, and Commissioners present for roll call were Jon Lindgren, Brian J. Yosten and Matt Niewohner. Notice of the meeting was posted on the Boone County Website-Public Notices, in the Courthouse north entrance, and at the Albion Post Office; and published in the Albion News/Boone County Tribune and Petersburg Press on April 17, 2025; and the convened meeting was open to the public.

The agenda was posted on the Boone County website; posted on the information board located in the Courthouse north entrance; emailed to the Board of Commissioners; and emailed to the Elected Officials and department heads on Friday, April 18, 2025. Chairman Lindgren acknowledged the agenda and noted that the Open Meeting Laws are posted and available to the public. All who were present participated in the Pledge of Allegiance.

Motion made by Lindgren, seconded by Yosten to approve Resolution 2025-10 to vacate 170th avenue between 220th Street and 230th street, between section 5 and 6, all in Township 20, Range 7, West of the 6th P.M. for approximately 1 mile. Denny Johnson, Boone County Sherriff, was present to present to the Board a quote from Platte Valley Communications for the office's band on the Fairground Tower. Johnson informed the board that the Albion Volunteer Fire Department uses the fairgrounds tower, as it is a state powered tower. Johnson also informed the Board that there may be a price increase. The Board requested Johnson to reach out to Albion Volunteer Fire Department Fire Chief, Bruce Benne, to discuss the use of the Fairgrounds Tower. Johnson will provide an update regarding the Fairgrounds tower during the April 28th, 2025, Board meeting. No action taken.

Keith Marvin, Victoria Olson, Boone County Zoning Administrator, and Mark Wagner were present to present the Board an update to the Boone County Comprehensive plan. Beth Ferrell, Nebraska Association of County Officials representative, was present during an annual visit and gave the Board an update on legislative items. Ferrell informed the board about upcoming legislative bills and conference opportunities.

Ryan Young, Globe Life - Family Heritage insurance representative, was present to give the Board a policy overview and introduce life and accident insurance policy. Motion made by Lindgren, seconded by Niewohner to allow Ryan Young to contact Boone County elected officials regarding Globe Life - Family Heritage insurance policies.
