The following was found: Road is used by local traffic for farm and property access; Road is a no outlet road that leads to a dead end; A portion of this road has previously been vacated; Vacation would not cause any property to be land locked; Utility lines are in the County ROW and Three culvert over Bogus Creek. With the completion of the on-site evaluation, Stankoski recommended the portion also be vacated.

Lynn Kaufmann, Landowner, went through the history of the road and bridge/culvert. Believes that the road should remain open and opposes the vacation.

Francis Whidden, Landowner, collected eight local opinions/signatures that could not attend the meeting and all were opposed. Whidden feels like the County wants to vacate the road to rid the County of the responsibility of the culverts and maintenance of said culverts. Whidden opposes the vacation.

Denny Cruise, Landowner, opposes the vacation.

Virginia Whidden, Landowner, wants the representatives in power to handle this issue since it should not be a landowner issue and if the road vacation were to go through it would be a landowner issue. Whidden opposes the vacation.

General discussion over the silting situation with the Bogus Creek was had and Whidden stated that the creek is changing and may cause problems in the future. Whidden also stated that past commissioners in meetings as well as individual conversations had promised to keep the culverts clean.





An idea was proposed to change the road classification from local county road to a minimum maintenance road, but to allow landowners to put gravel on the road as needed after the gravel met the Highway Superintendent's approval. Further discussion on liability concerns were also discussed.
