Sock presented to the Board the 2011 Boone County Plan of Assessment for three years. State Statute 77-1311.02 requires the Assessor to present the Plan of Assessment to the County Board on or before July 31 each year and is due to the State Board by October 31<sup>st</sup>. The plan is for Boone County Assessment Years of 2012, 2013, and 2014. Motion made by Luettel, second by Tisthammer to accept and approve the 2011 Boone County Plan of Assessment as presented. Roll call vote: Yeas: Luettel, Tisthammer and Schuele. Nays: None. Motion carried.





Chairman Schuele recessed the Board of Equalization meeting at 11:59 A.M. Present for roll call yeas were Commissioners Schuele, Tisthammer, Luettel and Joyce Sock, Assessor. Nays: None. Motion carried.

Chairman Schuele reconvened the Board of Equalization meeting at 1:00 P.M. Present for roll call yeas were Commissioners Schuele, Tisthammer, Luettel and Joyce Sock, Assessor. Nays: None. Motion carried.

Four property valuation protests were scheduled. The Board of Equalization heard two property valuation protests. Protest No. 2011-2 was for Parcel No. 4935.00 – FR SW1/4SE1/4 of 21-20-6, Parkview Apts., Albion, by teleconference; Protest No. 2011-4 was for Parcel No. 44060.00 – FR NE1/4NE1/4NE1/4 of 9-21-5, Albion; Protest No. 1 was for Parcel No. 60780 – FR NE1/4SE1/4 of 23-19-8, Cedar Rapids, scheduled a teleconference hearing on July 25, 2011; and Protest No. 2011-3 was for Parcel Nos. 25700.00 and 25800.00 – FR NW1/4 of 26-20-6, Fr. Protest No. 2011-1 was for Parcel No. 60780 – FR NE1/4SE1/4 of 23-19-8, Cedar Rapids.

According to Nebraska State Statute 77-202.10, Sock reviewed the ownership and use of all cemetery real property that was granted an exemption. Sock found no changes for 2011. Sock presented the property owned and used exclusively for cemetery purposes without profit to either owner or user. Motion made by Schuele, second by Tisthammer to approve and authorize the Board of Equalization Chairman to sign the 2011 Cemetery exemptions as presented. Roll call vote: Yeas: Schuele, Tisthammer and Luettel. Nays: None. Motion carried.

The Board heard the valuation protest on July 11, 2011 for Protest Nos. 2011-2 and 2011-4 and July 25, 2011 for Protest No. 2011-1. Protest No. 2011-3 did not appear before the Board of Equalization. Dean Jacobs of Minnesota representing Cargill, Inc. is working with Joyce Sock, County Assessor regarding Protest No. 2011-3. The Board and/or Assessor's office planned to look at the properties upon consideration of the information presented. The Board and Sock explained formulas used for appraisals and valuations.



The Board finalized the 2011 Property Valuation Protest by concluding their actions on July 25, 2011. The Board and Sock discussed the four protests. Sock presented the recommendation for each protest. Motion made by Tisthammer, second by Luettel to authorize the Board Chairman to sign each protest form with the recommendation. Motion made by Tisthammer, second by Luettel to accept the Assessor's recommendation and all motions carried regarding the decisions on July 25, 2011.

Adjusting the valuation of Real Property to \$3,461,900 and Personal Property to \$1,310,444 on Protest No. 2011-3, Cargill, Inc., reviewed values, removed dryer and will put on Personal Property 2012, adjusted heat on Section 5.

Adjusting the total valuation to \$115,630 (land \$15,000; buildings \$100,630) on Protest No. 2011-4, Todd Erskine, adjusted value until remodeling is done.

The Assessor completed the notice of decision on Form 422 for Protest Nos. 2011-1, 2011-2 and 2011-4 for mailing on July 26, 2011, and Protest No. 2011-3 for mailing on July 29, 2011, to the respective protestor. The respective protestor has thirty days to protest the Board of Equalization decision.
