

BOONE COUNTY BOARD OF EQUALIZATION PROCEEDINGS
APRIL 14, 2025 ALBION, NEBRASKA

The Boone County Board of Equalization of Boone County, Nebraska, met at 10:00 A.M. on Monday, April 14, 2025, in the Commissioners Meeting Room of the Courthouse in Albion, Nebraska.

Chairman Yosten called the meeting to order and present for roll call were Commissioner Brian J. Yosten, Matt Niewohner and Jon Lindgren. Dan Lueken, County Assessor, was present to answer any questions. Notice of the meeting was posted on the Boone County Website-Public Notices, in the Courthouse north entrance and at the Albion Post Office; and was also given in advance by publication in the Albion News and Boone County Tribune and the Petersburg Press on April 9, 2025 and the convened meeting was open to the public.

The agenda was posted on the Boone County website; emailed to the Board of Commissioners; and emailed to the Elected Officials; posted on the information board located in the Courthouse north entrance and emailed to the Department Heads on Friday, April 11, 2025. Chairman Yosten acknowledged the agenda and noted that the Open Meeting Laws are posted and available to the public.

Dan Lueken, County Assessor, presented six tax list corrections for the Board to review.

The 2025 Tax List Correction No. 466 was prepared regarding taxes for the tax year 2024 on Real Estate Property ID: 0004014.00. Depreciation was entered incorrectly – clerical error.

The 2025 Tax List Correction No. 467 was prepared regarding taxes for the tax year 2024 on Real Estate Property ID: 0006079.00. Should have been tax exempt – clerical error.

Dan Lueken, County Assessor, explained the tax list corrections to the Board.

Motion made by Yosten, second by Lindgren to approve the 2025 Tax List Corrections No. 466 and 467 as presented and attached hereto as part of the proceedings. Roll call vote: Yeas: Yosten, Lindgren and Niewohner. Nays: None. Motion carried.

The respective owners of the above-mentioned parcel numbers will receive a copy of the valuation change(s) and may appeal the Board's action within thirty days after the mailing of the notice. A condensed form of the valuation adjustments of the above-mentioned parcel numbers will be emailed to the Nebraska Department of Revenue, Property Assessment Division. Per §77-1736.06, the Board of Equalization hereby waives the notice requirement when the refund is less than two hundred dollars.
