## BOONE COUNTY BOARD OF EQUALIZATION PROCEEDINGS MAY 12, 2025 ALBION, NEBRASKA

The Boone County Board of Equalization of Boone County, Nebraska, met at 9:52 A.M. on Monday, April 14, 2025, in the Commissioners Meeting Room of the Courthouse in Albion, Nebraska.

Chairman Yosten called the meeting to order and present for roll call were Commissioner Brian J. Yosten, Matt Niewohner and Jon Lindgren. Dan Lueken, County Assessor, was present to answer any questions. Notice of the meeting was posted on the Boone County Website-Public Notices, in the Courthouse north entrance and at the Albion Post Office; and was also given in advance by publication in the Albion News and Boone County Tribune and the Petersburg Press on April 30, 2025 and the convened meeting was open to the public.

The agenda was posted on the Boone County website; emailed to the Board of Commissioners; and emailed to the Elected Officials; posted on the information board located in the Courthouse north entrance and emailed to the Department Heads on Friday, May 9, 2025. Chairman Yosten acknowledged the agenda and noted that the Open Meeting Laws are posted and available to the public.

Dan Lueken, County Assessor, presented two tax list corrections for the Board to review.
