# BOONE COUNTY PLANNING & ZONING COMMISSION RECORD OF MINUTES OF MEETING

**DATE: July 28, 2025** 

### 1. CALL TO ORDER

The July monthly meeting of the Boone County Planning and Zoning Commission was called to order by Brad Stephens in the Multipurpose Room in the Boone County Courthouse located at 222 South 4<sup>th</sup> Street Albion Nebraska, Monday, July 28<sup>th</sup>, 2025, at 7:30 p.m. Stephens noted that a copy the Open Meetings Act was posted, and copies were available for the public. The agenda for this meeting was given in advance to all members of the Commission. Notices for this meeting and public hearings were given in advance by publication and posted on the bulletin board located outside the zoning administrator's office. All proceedings shown hereafter were taken while the convened meeting was open to the public.

- 3. <u>APPROVAL/DISAPPROVAL OF June 23<sup>rd</sup>, 2025, Meeting MINUTES</u> for the planning and zoning meetings. Stephens asked for a motion of approval or disapproval of the minutes. - 4. Public Hearing to consider, review, and take necessary action regarding a Letter of Intent and an Ordinance for the Annexation of a tract of land received by the Cedar Rapids Village board. The tract of land is located in a part of the SW ¼ of section 5 township 18 Range 7 west of the 6th pm of Boone County NE. Stephens asked for a motion to open the public hearing. Groeteke motioned to open the public hearing with Tenski seconding the motion. Vote Ayes: Tenski, Stephens, Groeteke, Tenski, Stuhr, Langan, Braun. Nays: None. Absent: Frey, Wagner, Baum.

Olson explained that we originally had a public hearing for this in May but after some further research we realized that the public notice was sent wrong. Olson and the village board decided to re-do the public hearings to ensure the process is done right. The board had their meeting on July 2<sup>nd</sup> and recommended their letter of intent at that time. Olson stated that the annexation meets zoning regulations, and public notices were sent correctly. It is currently industrial zone and the board discussed that if they ever want to use the land for housing it would have to be rezoned as residential at that time. Stephens asked for comments from the public, none given. Stephens asked for a motion to close the public hearing. Tenski motioned to close the public hearing with Langan seconding the motion. Vote: Ayes: Braun, Stephens, Groeteke Tenski, Stuhr Langan, Nays: None. Absent: Baum, Frey, Wagner. Stephens asked for further comments or questions, none given. 5. Public Hearing to consider, review, and take necessary action on a conditional use permit submitted by Patrick Erwin with Skyward Landing Services to build a new cell tower. The parcel of land is located on section 30, township 20, range 6 of Boone County NE and is owned by Timothy and Amy Shanle. Stephens asked for a motion to open the public hearing. Stuhr motioned to open the public hearing with Groeteke seconding the motion. Vote Ayes: Tenski, Stuhr, Stephens, Groeteke, Langan, Braun, Nays: None. Absent: Frey, Wagner, Baum. Stephens asked for comments from the public, Patrick Ewin is the applicant and is representing his client who is wanting to put up the proposed cell tower. Erwin stated that it is a self-supporting tower and will have no guide wire. He also went into more detail about the application. The tower is also designed to hold up to 4 carriers including Verizon. Erwin also brought up that the proposed tower will be located directly south of an existing tower owned by American Tower corporation notify the County that they would be willing to work with the applicant with the proposed new tower on a solution as a suitable alternative since the current tower is less than 1000' of the proposed new tower facility. Erwin followed up stating that Verizon is currently located on the existing tower and Verizon lease at its expiration and has not come to an agreement on terms and will not. Verizon hired Tillman infrastructure to find them a new location. General discussion continued about the application and the tower. Stephens asked for a motion to close the public hearing. Tenski motioned to close the public
